# T-SOUTH BIDDABLE IT SERVICE

#### DEFINITIONS

- 1. In this Tariff Supplement:
  - a) "<u>Bid Price</u>" means the toll specified by the Shipper in a nomination for T-South Biddable IT Service given to Westcoast in accordance with Section 4.05 of the General Terms and Conditions.
  - b) "<u>Floor Price</u>" means the price equal to the Commodity Toll for AOS and Interruptible Transportation Service – Southern specified in Appendix A of the Toll Schedule for Transportation Service - Southern.
  - c) "<u>T-South Biddable IT Service</u>" means any Transportation Service Southern, provided as Interruptible Service between June 1, 2023 and December 31, 2026.

All other terms used in this Tariff Supplement shall have the same meaning as set forth in the General Terms and Conditions and the Toll Schedule for Transportation Service -Southern.

# MODIFICATION OF THE GENERAL TERMS AND CONDITIONS AND THE TOLL SCHEDULE FOR TRANSPORTATION SERVICE - SOUTHERN

2. This Tariff Supplement modifies the General Terms and Conditions and the Toll Schedule for Transportation Service - Southern in respect of T-South Biddable IT Service and the General Terms and Conditions and the Toll Schedule for Transportation Service – Southern shall be subject to and read together with this Tariff Supplement. For greater certainty, the General Terms and Conditions apply to T-South Biddable IT Service except as modified by this Tariff Supplement.

# APPLICATION

3. This Tariff Supplement applies to all T-South Biddable IT Service and will be effective from June 1, 2023 to December 31, 2026.

#### PURPOSE

4. The purpose of this Tariff Supplement is to provide the terms and conditions under which Westcoast will provide T-South Biddable IT Service pursuant to Section 5.1 of the 2022 to 2026 Transmission Toll Settlement dated November 3, 2022.

## NOMINATIONS

- 5. Any nomination given by a Shipper to Westcoast for T-South Biddable IT Service, in addition to those requirements set out in Section 4.06 of the General Terms and Conditions, shall include the Bid Price which shall not be less than the Floor Price.
- 6. Where a Shipper has given a nomination to Westcoast for two or more days and the Floor Price is adjusted for the second or any subsequent day specified in the original nomination resulting in the Bid Price specified in the nomination being less than the Floor Price for such day, Westcoast will not authorize any volumes for the account of such Shipper for such day unless the Shipper has changed the original nomination in accordance with Section 4.07 of the General Terms and Conditions such that the Bid Price is above the Floor Price for such day

# PRIORITY

7. Notwithstanding Subsection 3.03e) of the General Terms and Conditions, if Westcoast determines that the capacity available on any such day in T-South or any part thereof will not be sufficient to permit Westcoast to authorize all of the T-South Biddable IT Service nominated by Shippers for the day, Westcoast will allocate the available capacity between the affected Shippers in descending order on the basis of the Bid Price specified in each nomination given by those Shippers for the day.

# CURTAILMENT

8. Notwithstanding Subsection 3.04a) of the General Terms and Conditions, if at any time after Westcoast has authorized Firm Service, including diversions, AOS and Interruptible Service for any day in any Nomination Cycle pursuant to Section 4.09 of the General Terms and Conditions, Westcoast determines that the capacity available in T-South or any part thereof is not sufficient to permit Westcoast to provide all of the service and diversions so authorized for that day, Westcoast will first curtail or interrupt T-South Biddable IT Service which has been authorized for that day in accordance with Section 4.09 of the General Terms and Conditions in ascending order on the basis of Bid Price of such service so authorized.

#### MONTHLY BILL – T-SOUTH BIDDABLE IT SERVICE

- Notwithstanding Section 6 of the Toll Schedule for Transportation Service Southern, the amount payable by a Shipper to Westcoast in respect of T-South Biddable IT Service shall be an amount equal to the sum of:
  - a) the product obtained by multiplying the Bid Price by the Receipt Volume for such T-South Biddable IT Service (as determined after applying the rules set out in Section 5 of the Toll Schedule for Transportation Service - Southern) at the point from which the residue gas is sourced, which is thermally equivalent to the volume of residue gas (i) delivered to or for the account of Shipper at the Delivery Point, or (ii) transmitted through T-South for the account of Shipper on each such day during the month;
  - b) the product obtained by multiplying the difference between:
    - the Bid Price and the taxes on fuel gas that would be payable for gas delivered from the Receipt Point specified in the Firm Service Agreement to the Downstream Delivery Point; and
    - (ii) the Commodity Tolls and the taxes on fuel gas that would be payable pursuant to the Toll Schedules for Interruptible Service for gas delivered from the Receipt Point specified in the Firm Service Agreement to the Delivery Point specified in that agreement

by the volume of gas deemed to be diverted to a Downstream Delivery Point in accordance with Section 5(c) of the Toll Schedule for Transportation Service - Southern on each such day during the month; and

c) the amount of tax on fuel gas consumed in operations payable under the *Motor Fuel Tax Act* (British Columbia), the *Carbon Tax Act* (British Columbia), and the *Greenhouse Gas Pollution Pricing Act* (Canada) which is allocated to Shipper by Westcoast for each day in the month.
